Lately,the stock has been in a steady uptrend. On daily scale, we can observe a breakaway gap which augurs well for the stock price to continue its current momentum. On top of that the stock price has been comfortably moving above its 50 & 200 day moving average which indicates underlying trend for the medium term is bullish. Meanwhile the stock has came out of its 5 years consolidation; during this span the stock was seen moving in a range of 600 points (800–1400) which opens up a possible target price of 2000+ levels.

Technically, any closing above 1730 will confirm fresh breakout. The regular time to time pause is helping it to strengthened the possible up move. The RSI in weekly scale is well placed above 65 which is comfortable level to accumulate. The Relative strength in chart hints at continuing out performance. We see a 35-40% upmove over the coming months.
